**FCC Commissioner Jessica Rosenworcel to Deliver
Keynote Address at COMPTTEL PLUS**

WASHINGTON, D.C. – [FCC Commissioner Jessica Rosenworcel](#) will be the opening keynote speaker at the [COMPTTEL PLUS Fall 2015 Business Expo](#), which is taking place October 18-21 in San Francisco. In a Keynote Conversation with COMPTTEL CEO Chip Pickering on Monday, October 19, at 9 a.m. (PT), Commissioner Rosenworcel will provide attendees with insights into the communications landscape and current priorities at the Federal Communications Commission.

“From her time with the FCC and on Capitol Hill, Commissioner Rosenworcel understands the importance of a competitive marketplace for fostering economic growth, enhancing educational opportunities and enriching our civic lives,” said COMPTTEL CEO Chip Pickering. “She is a tireless advocate for our children, the future of education, and bringing the benefits of broadband and the digital age to schools and libraries through the E-rate program. No one has done more to raise the importance of the homework gap for low-income students. In addition, she has worked to ensure there is sufficient wireless spectrum to support telehealth and other core initiatives. We look forward to hearing from her about the topics taking precedence at the Commission and her vision for the future of the industry.”

Commissioner Rosenworcel joined the FCC in May 2012, bringing a decade and a half of public and private sector communications law experience to her position on the Commission. Prior to joining the agency, she served as senior communications counsel for the United States Senate Committee on Commerce, Science and Transportation. In this position, she was responsible for legislation, hearings and policy development involving a wide range of communications issues, including spectrum auctions, public safety, broadband deployment and adoption, universal service, video programming, satellite television, local radio and digital television transition.

Before joining the staff of the Committee, she served as legal advisor to former FCC Commissioner Michael J. Copps and legal counsel to the Chief of the Wireline Competition Bureau, and practiced communications law at Drinker Biddle and Reath. She is a native of Hartford, Conn., and is a graduate of Wesleyan University and New York University School of Law.
